- Manager's Report.
  - 1. Power washing went well.
  - 2. 20 condos got LED light bulb replacements (8-10 bulbs each).
  - 3. Irrigation project completed.
  - 4. WiFi Project completed & working well. Repair of railing & light fixtures are in progress.
  - 5. Landscaping going well with Ron from Puna.

- Unfinished Business: (Nothing emergent at this time.)
- New Business:
- Paint for the Cabana buildings lowest bid is \$50,000. Cherry picker is needed to paint eves & bid for this alone is \$30,000. Paint colors will match the cement buildings as closely as possible. Moved by Maria to paint the exposed pipes on cabana buildings to match the existing exterior & do "in-house." 2<sup>nd</sup> by Roma. Unanimous Yes. Total Cabana Painting Project will need to wait until 2017. Failing grout around pool needs to be repaired by Steve at Tamarock.
- Management Company Issues: Financials are mess. No monies are missing—just improperly accounted for. Payments to contractors & bills are not paid on time & are either incurring late fees. We've had 5 different account managers in less than one year. Phone calls & emails go unanswered. BOD is shopping for a new management company, & when decided upon, will require 60 days notice to severe contract. Another 60-90 days to transition all accounts to new company. Bruce & Maria will draft a response letter to Jon of Associa.

## Owner's Forum:

- Ed Gibbons: Proposal to investigate more ways to save electric energy- i.e. insulation of ceilings, new clothes dryers & other energy efficient appliances. Most people are reluctant to change their bulbs out for LED bulbs—so AOAO purchase bulbs for distribution. 20 units changed bulbs out so far. Bulbs should last about 8,000 hours up to 10 years. Maria & Ed to work together on this project. Suggested writing article/press release for newspapers about the solar project to boost Kalanikai reputation. Other suggestions are to start a Neighborhood Watch for property to protect from homeless/vagrant trespassing at night.
