- Approval February 15, 2020 organizational meeting minutes. Approved as submitted.
- Approval of Annual Meeting Minutes in draft form. Approved in draft form.
- Ratification of Email Votes if needed:
  - 1. Mango & autograph tree pruning. \$3000. Ratified.
  - 2. Bob Barrett \$75 for chicken feed. Ratified.

• Treasurer's Report: \$15,600 Reserves: 106038 receivables: 166,500 total asset 288,137 total liabilities: \$44,294, net worth: 253,843. \$498.000 for plumbing Insurance: Laundry: \$5,272.52 January 2020. Tracy will do the deposits in Ed's absence.

- Resident Manager's Report:
  - 1. WiFi update & upgrade. Must sign in every 2 hours. New passwords available from RM.
  - 2. COvid-19 Difficulty in finding bleach for the pool. Need concentrated, splashless liquid bleach.
  - 3. Hot water is repaired in Cabana 1 & 3 by changing the pumps out. Cabana 2 is still having problems. Note: the water cartridges in sinks & showers need to be changed every 5-7 years.
  - 4. Tree trimming will take place March 18, 2020 at 7am.
  - 5. One of the shed gates along Kuakini is falling apart. New gates \$2800. New ideas for the plastic shed? Perhaps remove the shed? Workshed area? Exercise equipment?
- Unfinished Business.
  - Update on triangle lot: Made an offer. Waiting for reply. (Side note: More homeless people are taking up residence in the lot in the last few weeks.)
  - Update on STVR permitting issue: Not finished with all applications from the Hawaii County Planning Department. So far, most applications were accepted.
  - Water monitoring technology-Ed presentation: PHYN freshwater monitoring. \$699 for one building detects water leaks, usage, temperature, etc. The Board will have RM investigate possibilities/advantages/requirements of installing this system.
  - How to deal with street use of visitor parking (low cost). Suggestion: If you witness suspicious activity please take a photo/video(with cell phone if available) & call the police. Vote: Move by Sheryl, 2<sup>nd</sup> by Bruce Vote 3-2 not to change

visitor's parking vs. rental spots. Smoker's Area is to be "Use at your own risk."

- Audits: Ed expressed concerns about inconsistency between years. The Reserves are out-of-whack from emergency projects with 4" drain lines & waste lines in the parking areas.
- Cabana Bldg door entry replacement proposal. To custom-make replacement doors would cost over \$1000 each. Challenges/low cost solutions-Stefan: Problems are: increasing noise from Henry St., security, light, ventilation, maintain the look & feel of Hawaiian cabana. Steel mesh security doors & clear, frosted or tented glass pre-hung steel door combination is recommended. Choice of steel vs. fiberglass. Estimate: \$300 each for 84" inside door. Combination is \$770.00 total. Each owner is responsible for their own door replacement. Option of adding wooden louvers \$180 plus tax. Stefan will send a proposal to cabana owners.

#### New Business:

- Late development involving WiFi potential options: Quotes for bulk rate coverages. Hawaiiantel: New package for MDU(multi dwelling units): \$27/unit all fiberoptics, WiFi, own modem, own internet connection, anti-spyware. New camera installation, WiFi coverage proposal TBA. Currently we have TV coverage for \$28. Current WiFi costs around \$4/month per owner. New program TBA.

- Owner's Forum:
  - \*COvid-19 has forced total lockdown in many areas on the mainland USA. The Board is keeping alert to changes and challenges this may present for Kalanikai.
